



2023 QLD QCSA TEAM NOMINATION

PROCESS

ALL PLAYERS wishing to nominate for the U14 mixed, U17 Girls, U17 Boys, U21 Men, Senior Women and Senior Men teams need to:

1. Pay the nomination fee of \$350 (refunded if not selected) via EFT into their Zone bank account. Reference must include the player's surname and team (e.g. Smith U16Girls). Cash and cheques are not being accepted this year. The \$350 nomination fee will be used as the first payment towards tour fees for selected players. Failure to pay the nomination fee will result in the automatic withdrawal of the player's nomination by the National Committee.
2. Complete the attached nomination form and return to your team manager by Wednesday 19th April 2023.
3. Any player who is approached by selectors during the State Carnival tournament and agrees to being looked at for additional selection, must have their paperwork given to National team manager by Monday the 1st of May (before the end of the Carnival). Nomination money is to be paid to QCSA by 5pm on the 8th of May 2023. If not, then the nomination falls void.
4. During the tournament, players that wish to be looked at by the selectors but have not already put in the nomination form or paid money will need to speak to the National Coach or his staff. Rules as stated above apply for this nomination and payment process.

REFUND OF THE NOMINATION FEE

Refunds will be issued in one of the following ways:

1. Refunds for non-selected players will be paid after the announcement of the QLD teams. Zones will organise the refunds using the player account details on the nomination form.
2. Refunds will be issued for medical circumstances, upon receipt of a doctor's certificate. Refunds of nomination fees of selected players will be at the discretion of the National Committee.

Shadow players will be required to purchase the full kit, if it is their first year and replacement items for returning players. All uniform order forms must be signed by a parent/guardian, if the player is under the age of 18yrs of age, or the player, if they are over the age of 18yrs of age. Costs for uniforms will not be refunded to any player or shadow player past the uniform order cut-off date. Refunds may also be made of any other monies, other than uniform, paid to the QCSA by the shadow player if they are not called into the touring team.

APPEALS

There are no appeals on the selection of players. Selectors do not have to justify team selections to players/parents/coaches etc. Any appeals about compliance to rules and process in nominations or payments shall be directed to the National Committee.

Any player selected on the QLD National squad who receives a red card during the QCSA season, will be given the opportunity to show cause why they don't lose their position in the QLD National team. National Team staff will investigate the issue in the first instance.



2023 QLD QCSA TEAM NOMINATION FORM

Nominating players must pay their \$350 nomination fee into their Zone account and hand in their completed form to their team manager by **WEDNESDAY 19 APRIL 2023.**

TOUR CODE OF BEHAVIOUR AND CONDITIONS

1. Tour commences day of competition and continues until completion of Grand Final matches (29th September – 2nd October 2023 (inclusive).)
2. All players will comply with instructions from the coaches, managers and designated tour personnel at all times.
3. All players are required to remain with the QLD QCSA group at all times and participate in all activities conducted as a group during the tournament. Players and staff are expected to provide support to other QLD QCSA teams while not preparing for or playing a game.
4. Players are considered ambassadors of QCSA and will always act in a proper and respectful manner. Behaviour unbecoming a representative may result in expulsion from the team and/or the player being excluded from the remainder of the tour. QCSA By-Laws and Constitution are the basis on what forms acceptable and unacceptable behaviour.
5. Consumption of alcohol for the duration of the tour is **STRICTLY PROHIBITED.**
6. If selected, players are expected to attend all training sessions and practice matches organised by the coach or manager of the team. The coach or manager must be notified of any absence in advance of the session. Absence without significant cause or failure to attend training sessions may, at the discretion of the QCSA National Committee, result in the removal of the player from the squad.
7. All fees are to be met on time as prescribed by QCSA scheduling. Final deadline for full payment is 1st September 2023.
